PRESIDENT'S REPORT

2021 started with welcoming new members to the Board and the standing down of two of our long serving members Lyn Smith (Acting President) and Carol Harris OAM (Acting Secretary). Lyn and Carol have made an amazing contribution as members of the Association over many years. Their support for the Association continued into 2021 with them both continuing to attend meetings as delegates.

I moved into the position of President having had many years of experience as a NSW State and Australian Masters Player, Selector and former Secretary Hockey NSW Masters Board and President of St George Hockey Club. I have an all-consuming passion for the sport and celebrate in 2022 my 56th year in "Sydney Men's" grade hockey. (Covid permitted)

The committee also welcomed a new Secretary Sue Woodger. Sue has been involved in hockey as a Committee Member for Sharks Hockey Club and as a player for many years. The Board also welcomed Jen Palmer from RSL into the role as Director of Marketing and Communications. Jen is also long-standing hockey player and is also President of RSL Hockey Club. Finally, we also welcomed back a new Director of Representatives during the season. Craig Holmes re-joined the committee after a few years absence.

With our new committee members, we welcomed a new season. The 2021 season was marred with a few disappointments and **major achievements**. The committee engaged in Term 2, a hockey program to encourage new players to the sport and to help grow our junior base which was very successful. Some 40 new players participated and we look forward to a similar program next year. With our limited season, we were able to host the NSW Combined High Schools Hockey Competition at Marang, which was a great success with many comments that we have the best community sporting facility of its kind.

Unfortunately, COVID put a sudden end to 2021 season in June. However, before the sudden end to our season we were able to achieve representative success. Our Under 18s and Under 15s boy and girls both managed to have their State Championships, with both the girl's teams finishing top 2 in their pool and playing off for a spot in the Final. A highlight for the representative season was the Open Women winning Division 2 and progressing into Division One. This is a major achievement for the Association who have been striving for this success for many years. Our Senior Masters team again won the 1st Division State Title, making it the most successful team in the state's history.

Our disrupted hockey season did not stop progress at Marang. We were successful in obtaining a Community Sports Grant, resulting in the purchase numerous benches for our spectators to watch the game and tables and chairs for players and friends to socialise after a game.

With the softening Covid restrictions in society, we were able to run a short six-week summer competition that allowed many players to get back onto the pitch and enjoy some hockey. We expect to start up in mid- January for those keen to play.

In closing I personally wish to thank all those volunteers who give their time to make things

happen. A big shout out to all our Club Administrators, Club Delegates, coaches, managers and umpires who supported our short hockey season. A big thanks to HNSW for their direction and support.

Our Association is in need of motivated people. If you are unable to serve as an active board member you can always help in areas such as marketing concepts, promotions or access to the various schools in our region. It does not have to be you, if you know someone such as a student studying sports management looking for experience or a retired business person, not yet ready to call it a day and considers they still have unfinished business and are able to help in some form, our hockey community. Any help would be great-fully appreciated.

To all our players **thank you, thank you, thank you** for your continued participation in the sport that we all love and I look forward to seeing you all early in 2022. Please if you know of anyone, whose is interested in playing, no matter what level, we need them. Only too happy to provide existing and new players coaching at any time.

DIRECTORS REPORTS

COMPETITIONS

Well..... 2021 was the reverse of 2020. We got our season off the ground and running in March, only to be brought to an abrupt halt in June.

With the season over after only 6 - 10 games, we had no finals, no premiers and no awards. In a way the 2021 season was more disappointing than the 2020 season, which although short, did have a resolution.

Junior numbers were greatly depleted following the drop off in 2020. This was likely partly due to the impact of COVID on team numbers and hence competition depth in 2020 as well as families continuing to adopt a slower pace of life post the 2020 lockdowns. Hopefully after two lean seasons, we can come back stronger in 2022.

There was some excitement to report in junior ranks however, with the success of the infants and primary aged skills and games run on Wednesday afternoons in term 2. From all reports this was a great program with lots of new players attending and some new (and old) faces putting their hands up to run the program and coach the kids each week. Congratulations to all involved. The intention was to resume the program in term 4, but with schools not back at the beginning of the term we were unable to run the term 4 program. Let's hope we can build on this in 2022 and run full term 2 and term 4 programs.

We have been able to run a short summer season. Once again, Jodie McIntosh has taken the running with summer hockey, organising the competition, the fields and being there on a Tuesday to open/close and umpire. We have three competitions running on a Tuesday evening at Marang, with 6 junior teams, 4 mixed teams and 8 ladies' teams. The indoor/summer competition at Marang is building year on year and hopefully we can see it continue to grow. With the timing of the lifting of restrictions, we were able to schedule a 6 round competition finishing up before Christmas.

Junior Winter Field Competition

We had teams in the junior competition from Bosco Hockey Club, Cronulla RSL Hockey Club, Sharks Hockey Club and Tartans Hockey Club.

Unfortunately, we were only able to run a high school aged competition. This competition was run on Friday nights. As there was a bye, teams did not have an even number of games and most teams only got to play 6 rounds. The teams entered in the High School competition were Bosco, Killer Sharks, Cronulla RSL QuickSticks, Cronulla RSL Red Rockets and Tartans Trojans.

Senior Field Competition

The ladies senior competition was played on Saturday afternoons at Marang. This season saw 6 teams compete an 11 a side competition. Unfortunately, Sharks were unable to commit to an 11 a side competition this year, but hope to be back next year. The easing of COVID restrictions this season allowed the social side of drinks after the game to resume this year. There were 6 teams in the competition and all teams were able to play 10 games. The teams entered in the competition were Tasers, Anacondas, Gold, Brumbies, Clydesdales and Tarts.

It was disappointing not to be able to conclude our season with the celebrations surrounding finals games and presentation of awards.

Thank you to all teams for taking on the duties and canteen staffing for the weeks we were able to play. Everyone did their requested duties and that certainly makes everything easier for the Board.

Umpires

Of course, we cannot play without umpires. Thanks to our Convenor Bridget Crowley and to all the kids and adults who put their hands up to take on umpiring in 2021. We had a number of junior umpires in 2020 who were unable to umpire with us in 2021 due to the lack of competitions. It was good to see Hamish and Eliza step up from umpiring junior hockey to regularly doing ladies games this year. Thanks to – hopefully I will remember everyone: Alex E, Bridget, Courtney, Eliza, Ella, Hamish, Jack, Jenny, Luke, Mackenzie, Mahalia and Morgan.

Judiciary

Unfortunately, there were four issues of teams playing illegal players in the 2021 season, resulting in loss of points. One junior team and one senior team played illegal unregistered players in round 1 and lost points. Two senior teams played illegal reserves in a later round (too many players participating in the game). Both teams lost points. All point losses were considered by the Judiciary Committee before being applied.

It was great that the Judiciary did not have to meet for any disciplinary issues.

Grading Committee

The Grading Committee was again chaired by Marisa Dalla-Bona, and had members from the four clubs playing in the local competitions – Melissa Mecham, Sherryl Arredondo, Sue Woodger and Beth Tully.

Final Thanks

Thank you to everyone who contributed to our (short) competitions in 2021. Everyone who served in the canteen, stocked up the ice in the dug outs, opened up, locked up and cleaned the toilets made a valuable contribution.

Due to other commitments, I was unable to continue in the Competitions Director role for the full season and resigned from the position in early July. I did continue as Fixtures Convenor and Judiciary Convenor (although those roles did not involve much after that date). I have enjoyed being involved with the Competitions and Fixtures roles in the Association since the 2010 season (after a stint in the 1980s as well) but it is now time to hand off to someone else. Thank you to everyone who has assisted me over that time and best wishes to next year's Competitions team.

We were able to field 8 women's teams, 4 mixed teams and 6 junior teams. It was great to see everyone back on the pitch enjoying their hockey again. We made new rules and made the mixed team play with minkey goals which added to the fun. The Association also ran a mixed game on a Saturday afternoon which saw players from across the Shire come together for a fun but competitive game of hockey.

A big thank you to Jodie MacIntosh and Jodie Flack for helping run the competition and Rick McConnell who set up all the boards for the summer competition and all the players who umpired games. We saw many people return to hockey who had not played for a while.

Despite the Indoor National Championships being cancelled for a 2nd year in a row, the NSW State Indoor Championships have been rescheduled until January 2022. Sydney South will be fielding a team in every age group at the State Championships. The Under 15 boys and Girls were invited to compete in the Sydney Indoor Hockey tournament at Mosman. This was the first time Sydney South competed at this tournament. We hope to continue to field teams at this carnival.

Once again thank you to all the coaches, players and umpires who supported this competition and who will be participating at the NSW Hockey State Championships.

FACILITIES REPORT

In the absence of a Facilities Director, I have continued to carry out some necessary work at Marang, with a great deal of help from my husband Ken, and a number of other faithful volunteers.

We started with the construction of a timber floor on which to sit the proposed shed for the ride on mower. During some very hot weather, Lyn and Ron Smith helped with this project, and in yet more heat Nathan and Jodie Flack helped to erect the shed. Thank you so much all of you for your continued help and support for the association. A while later, we realised that the roof of the shed needed more support than provided by the bracing supplied, so Ken and I also fixed that.

Once we had the shed finished, Rick and Lyn moved the tubs containing archives, annual reports and photos from the storeroom and container to the shed, to enable us to upgrade the container and storeroom.

The container was cleaned, left-over turf cut to size and installed at the front of the container, shelving was bought and erected at the back and archives etc moved back into the container. Table and chairs were cleaned and moved into container for use by CHS officials. Justine now has all her rep uniforms stored there, safe and dry.

Ken refurbished the trophy cabinet which we rescued from the change rooms at Jenola. It is now on a plinth attached to the wall of the container and holds all our trophies which were in plastic tubs gathering dust and grime in the storeroom. All trophies have been repaired and cleaned.

The storeroom was cleaned and shelving installed on the right-hand wall. Shelving now holds training equipment for Tomahawk Academy, and provides room for clubs to store a goalie kit. There is now room to store stock for the canteen as well as all the equipment and supplies for the coffee machine. Our old BBQ is now used as a work bench when the coffee machine is in use, and the new one now has a cover and is left out under cover of the newly-enclosed area outside the canteen. Ken also had to be a plumber for a while and move a tap to provide water for the coffee machine so it is inside the fence and accessible for Lyn. Whilst in the mood, he also hung hooks outside the storeroom and male toilets to hold hoses so they are close to the taps.

As requested by board members and players alike, we also sourced, ordered and fixed the metal panels to the top of the dugouts and tech benches to prevent rain and water from the water cannons from entering. A very successful project!

Although not strictly maintenance for the fields, we partially repaired the damage to grass and landscaping caused by traffic outside the main entry gate. We were hopeful that new signage on Captain Cook Drive would mean fewer drivers would mistake our entry for the entrance to the Recycling Centre and wouldn't be backing out over the landscaping - not so, unfortunately – in one 40-minute period, whilst waiting at the gate for timber to be delivered, we counted 10 cars turn into our entrance whilst looking for the skate park. Obviously, the signage is not bold enough!

Early in the year a pest exterminator was called in to deal with the many and various critters around the building and tech benches. A lot of redback spiders had been found, but since spraying I am happy to say the only nasties now are dead ones. We will be keeping a close eye on them

though, and I have told the company carrying out the extermination that they will be needed again early next year, just to make sure.

Lyn also followed up with maintenance and repairs to the water cannons, and the company has suggested ways to overcome the lag in switching off some of them – we went into lock-down again before being able to fine-tune this to make sure it works.

The fields were cleaned in March, prior to the competition starting, and will be cleaned again before the 2022 season. Many thanks to Breen's Resources for their continued support in keeping our fields in such good condition. Thanks also to Lyn who continues to mow the grass surrounds and keeps everything looking good.

So much for maintenance, but we have also been busy in making our facility a more attractive and user-friendly venue – Rick coming up with the ideas and Jenny Palmer coming up with the grant funding. Our club banners look terrific along the road and at the car park entrance on game days, put up each time by Rick, and the club logos on the wall outside the changeroom shows everyone just who belongs to the Sydney South Hockey Association. We now also have lots of bench seating and picnic tables on timber platforms at either side of the amenities block, as well as outside the container. Rick put the benches and tables together as well as doing the preliminary preparation work for the platform, which was finished off by Ken and Carol, with very welcome help to finish off laying the timber sleepers from Rick, Jenny and Jamie Palmer. Excellent work by everyone.

The actual 2021 season had been building to be our most successful yet, with bookings for the CHS Boys State championships and the NSW U21 training sessions. We also had the SEHA Junior and SEHA Schoolgirl competition booking out both fields for the entire Saturday morning, as well as increased bookings from SEHA women's competition. Hopefully, this will continue for the 2022 season, with Independent Girls Schools taking over the running of the schoolgirl competition, and booking both Term 2 and Term 3.

Prior to starting our half-field summer competition in November, Rick carried all the boards from storage and laid them out on the fields – he says it keeps him fit, but thanks anyway Rick!

With increased usage comes the need for an increase in member participation off the field, as well as on the field. There are lots of ways people with limited time can help – please just ask a member of the board what you can do – lots of things only take 15 minutes or so either before or after your game and that will take the pressure off the few already doing it all.

Looking forward to our AGM when people can volunteer for all sorts of things, and to a full and successful 2022 season.

Hockey Skills Academy

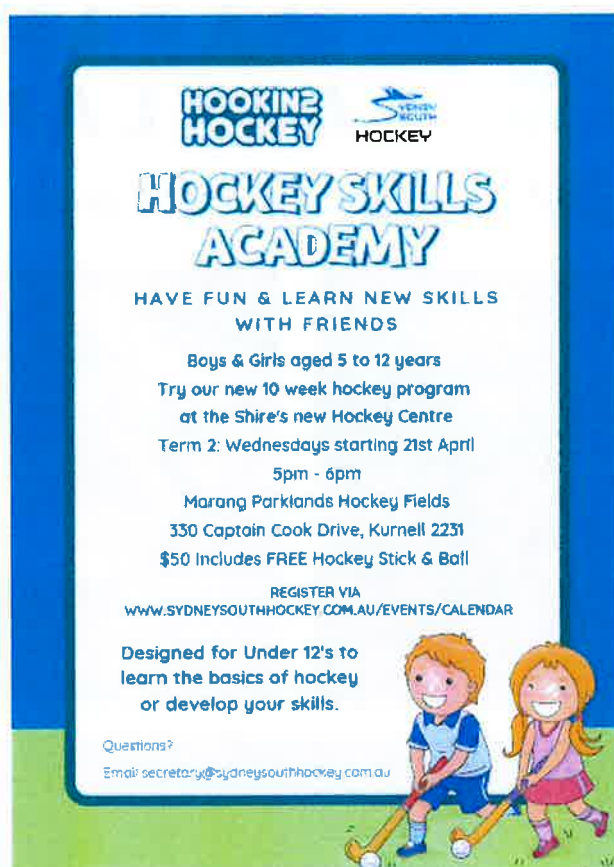

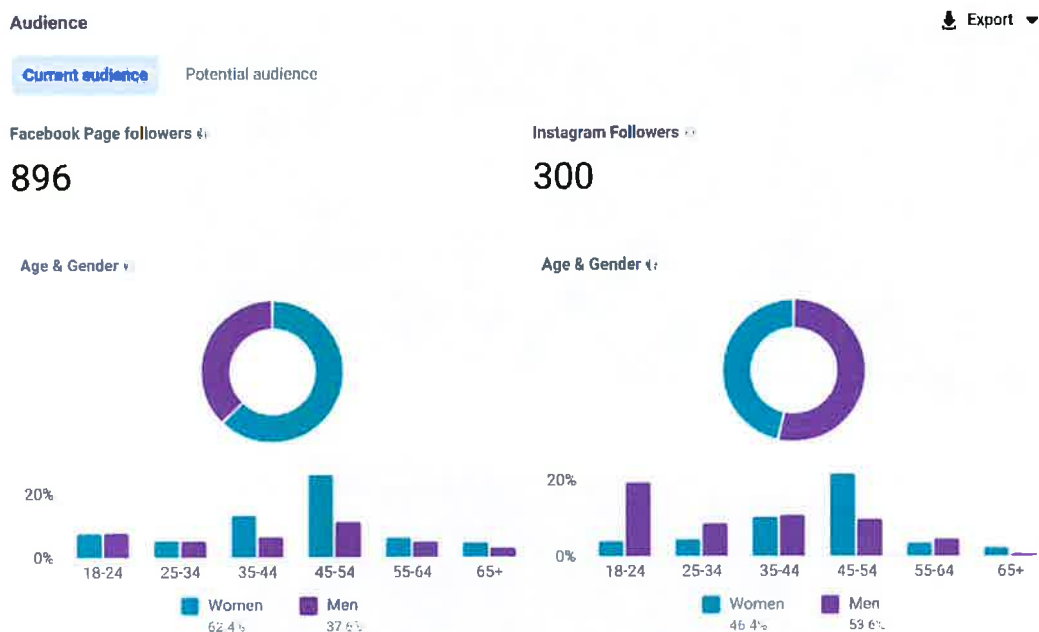

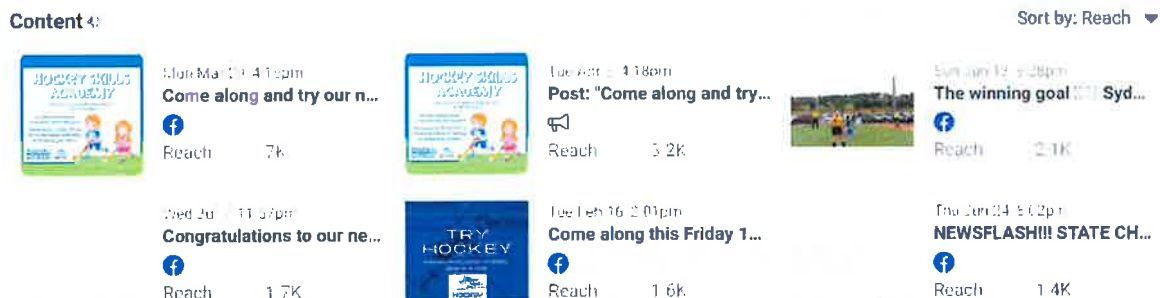
We have a solid audience following SSHA on Facebook and Instagram. It is one of the best ways we can communicate news to our members apart from email.

ACTIVITIES 2021

REPRESENTATIVES

The year of 2021 was another successful year for Sydney South Hockey Association. Unfortunately, COVID-19 played its part in changing some of our processes and policies. A major victim was the indoor hockey season which was cancelled due to the virus. However, we managed to fit nearly an entire field hockey program into 2021.

The 18 girls carried their 2019 runner up result with a third placing and our 15 girls displayed our depth with a 4th placing in division 1. ALL our women's teams are in division 1 in 2022 after the women's team finally broke the hoodoo after years of being in the division 2 finals. Our men's team made the division 2 grand final again but fell short and I am sure they will regroup for 2022.

Unfortunately, our red hot under 13 boys' team, who were in division 2, couldn't have a shot at gaining promotion to division 1. They defeated the 2021 state champions Newcastle 4-0 in Canberra and were red hot favourites to win division 2.

STATE CHAMPIONSHIPS REPORTS

OPEN WOMEN

All good dramas have six parts follow our path to be Division 2 State Champions. With only six teams in Division 2, we played 5 round games with the top 2 teams playing the final.

Day 1 Game 1 v Lithgow - The first quarter was frantic but the team settled for the remainder of the game to dominate field position and maintain good control with the ball. However, the opportunities that were created in the circle were not converted. The result was a narrow 2-1 loss with an amazing goal from Beth standing in the perfect position on the post to deflect the ball in. In what can only be described as a slow start to the State Championships, this was a game we should have won but its great learning opportunity for everyone.

Day 1 Game 2 V Sydney East - Our second game saw some positional adjustments and the team came out firing with a goal from Lis in the first 30 seconds. Two beautiful short corner conversions saw a bottom left cracker from Yas and a lob over the keepers head from Lili. A strong 3-0 win in the local derby. This game saw a better understanding of each players style and skills and the opportunity to test some short corner options.

Day 2 Game 3 v Coffs Coast - Our first half was a mental battle with tight and sore bodies from day 1 struggling to stay in a 1-1 game at the break. The coach didn't get the opportunity to address the team at halftime as Yas was on a mission, channelling a higher power and delivering an impassioned speech that was heard on the other side of the field. It worked, a strong second half had Tiahna scoring twice for a 3-1 win.

Day 2 Game 4 v New England - Off to a flyer with two quick goals in the first quarter that were equalised by New England by halftime. With a goal each in the third quarter leaving the game open evenly poised. Lili scored a beautiful deflection goal in the final quarter for a 4-3 final score with Tiahna scoring a hat trick. A game with continued improvement and development from the team that had them pulling ahead in the final quarter of a tight match.

Day 3 Game 5 V Goulburn - Goulburn were undefeated and we needed to win to make the final. Unfortunately, Lis' tournament was over unable to play due to a hamstring strain but she shared her experience and knowledge with everybody in a tight and tense match that was 0-0 at the start of the final quarter. A plan was hatched with Natasha for her to stand in front of the keeper where she received a beautiful pass that she casually deflected between the keepers legs for a 1-0 win.

Day 3 Final V Goulburn - Round 2 for the day, we knew Goulburn would come out hard in this match. Goulburn's pressure was relentless in the first quarter seeing them gain an early 1-0 lead. In the second quarter the team settled, focused on our game and continuing our weekend of improvement. In the third quarter Natasha was wreaking havoc in the circle again and was taken out by the keeper resulting in a penalty stroke being awarded. Yas scored to bring us back to 1-1. The score remained locked at 1-1 with Christine repelling all of Goulburn's attacking raids.





NOTES TO THE FINANCIAL STATEMENTS

The financial statements cover SYDNEY SOUTH HOCKEY ASSOCIATION INCORPORATED as an individual entity. SYDNEY SOUTH HOCKEY ASSOCIATION INCORPORATED is a not for profit Association incorporated in New South Wales under the Associations Incorporation Act 2009.

The functional and presentation currency of SYDNEY SOUTH HOCKEY ASSOCIATION INCORPORATED is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

1 Basis of Preparation

In the opinion of the Committee of Management, the Association is not a reporting entity since there are unlikely to exist users of the financial report who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the Act.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

The financial statements have been prepared on a cash basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Significant accounting policies adopted in the preparation of these financial statements are presented below and are consistent with prior reporting periods unless otherwise stated.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of this financial report.

Impairment of Non-Financial Assets

At the end of each reporting period the association determines whether there is an evidence of an impairment indicator for non-financial assets.

Where this indicator exists and regardless for goodwill, indefinite life intangible assets and intangible assets not yet available for use, the recoverable amount of the asset is estimated.

Where assets do not operate independently of other assets, the recoverable amount of the relevant cash-generating unit (CGU) is estimated.

The recoverable amount of an asset or CGU is the higher of the fair value less costs of disposal and the value in use. Value in use is the present value of the future cash flows expected to be derived from an asset or cash-generating unit.

Where the recoverable amount is less than the carrying amount, an impairment loss is recognised in profit or loss.

Reversal indicators are considered in subsequent periods for all assets which have suffered an impairment loss, except for goodwill.

Cash and Cash Equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

Revenue and Other Income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the association and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

Sale of goods
